1. REGISTRATION PROCESS

- Students are expected to register on line.
- Students paying their fees through Bank Loans should register manually. (See section 3.2)

2. REGISTRATION PERIOD (REGULAR & PRORATA)

4th January 2017 – 17th January 2017

Period	Total Payment
4 th January 2017 – 17 th January 2017	Fee + 2% NBT
18 th January 2017 – 22 nd January 2017	(Fee + Rs.4000) + 2% NBT
23 rd January 2017 – 31 st January 2017	(Fee + 10% + Rs. 4000) * 2% NBT

Course Fee Calculation

Ex :

Course Fee = 115,000/=

2% NBT = 2,300/=

Total Payment = 117,300/=

3.2 Payments made through Bank Loans

4.2 Students who are not registered on a regular basis during January - June in 2017.

- Students should register on a prorata basis for outstanding subjects.
- Those who have obtained pass marks in CA in June - December Semester 2015 to June - December 2016 will be allowed to use such marks under prorata registration and attempt the end semester examination only.
- This requirement needs to be communicated to Manager IPU in writing.
- Others, will have to repeat the entire module under prorata registration.
